### Prison Rape Elimination Act (PREA)

- If you or someone you know has been subjected to sexual violence or misconduct involving Louisiana Department of Public Safety and Corrections staff, please notify the warden's office where the person in prison is assigned or the Probation and Parole District Office where the person reports if they are under supervision.

- **Office of Juvenile Justice:** All reports of sexual abuse or sexual harassment will be investigated and addressed. Youth, employees, and third parties can report incidents of sexual abuse or sexual harassment in verbal or written

formats. All parties can file a report with the Office of Juvenile Justice by calling the Investigative Services hotline at 1-800-626-1430. Reporters can remain anonymous or provide contact information in the event more information is needed.

- **Orleans Parish Sheriff's Office:** The PREA hotline serves inmates as well as third parties, including family members, friends and volunteers (though third-party callers do not receive counseling services). The PREA Hotline number for the Orleans Parish Sheriff's Office is 504-717-2279
