## Dear Governor Edwards,

As faith leaders across Louisiana, we come together to ask that you exercise moral leadership and use the emergency powers at your disposal to save the lives of those incarcerated. Many of us minister in prisons, in jails and to those who have reentered our faith communities after returning; we know the dangers they face. The large population of elderly and sick incarcerated individuals was a moral stain on our state prior to COVID-19. However, we have run out of time to act.

We ask that you immediately activate the release of the elderly and the vulnerable held in DOC and ICE facilities. The spread of COVID-19 is a global catastrophe on a level that no elected official or policymaker in office has ever experienced before. History will ask how we worked in this moment to prevent suffering and loss of life for all of our community members, especially those we incarcerated.

With the highest rate of incarceration rate in the world, Louisiana has more people serving life without parole per capita than any other state. Many members of our congregations are already affected daily by the absence of loved ones from their lives. While struggling through this difficult time, they have the added hardship of knowing their detained family and friends cannot protect themselves from the rapid spread of COVID-19 while behind bars. We fear those in detention are being sentenced to death despite your power to release them. We fear for those who work as correctional officers, medical staff, chaplains, mental health providers, and all personnel. We are concerned for their families and communities as well. This virus does not know the boundaries of confinement.

We, the undersigned, call upon you to administer emergency powers and protect our most vulnerable before it is too late.
